

# Housing Options

## Community housing and low cost rental

### What is community housing?

Community housing provides long term housing, security and affordable rent for people on low incomes.

It does not refer to rooming /boarding house. Each person/household rents a self-contained unit. Community housing is not an emergency housing service. There is a single register for all community housing registrants.

Community housing providers are non-government, not-for-profit organisations operating under the *Community Housing Providers (National Law) (South Australia) Act 2013*. They are also subject to the *Residential Tenancies Act 1995*.

To be eligible people must meet:

- the government's eligibility criteria for all Community Housing; this includes residency, income, assets and needs tests
- the specific eligibility criteria of the individual housing provider in which they are interested.

Some community housing organisations some cater especially for people with special needs such as disability, mental health issues or who have experienced homelessness.

Many tenants require support services to maintain independent housing. These are provided by government and community service agencies, not necessarily the community housing provider.

Each organisation manages its own tenant selection processes. Some may require tenancy supports to be in place before a referral will be accepted.

A single form ('Registration of interest in housing') can be used for Housing SA and community housing accommodation. The form is available from the [www.sa.gov.au](http://www.sa.gov.au) website. If you register your interest for both at the same time, Housing SA will be your primary contact for information on your registration.

It is also possible to register for community housing only. In this case you can nominate your preferred community housing provider, which will become your primary contact. Before doing so it is recommended that you contact the provider to discuss your needs. They may assist you with completing the form.

**Volunteer member-tenant managed community housing** (also called housing co-operatives) are run by a group of people with a

common interest who work together to maintain and manage housing for their members.

Volunteer members perform landlord roles (e.g. tenancy, rent and maintenance) and business roles (e.g. administration, bookkeeping). Membership requires significant ongoing commitment, including attending meetings and actively participating in the management of the co-operative.

Each co-operative manages its own member and tenant selection processes. People interested in this housing type must complete the form *Registration of Interest*. The completed registration form should be posted to Housing SA Contact Centre, GPO Box 292, Adelaide SA 5001.

Community housing is only one of a number of affordable housing options. See other options below.

### Low cost rental accommodation

Low cost rental accommodation may also be offered by not-for-profit and community organisations specifically for seniors. They usually consist of one- and two-bedroom units and are specifically for older people who do not own their homes.

A low rent amount is charged and an assets test may be required. These are generally governed by the *Residential Tenancies Act 1995*.

### Supported rental accommodation

**Community houses** offer low cost bed-sitter housing for people who would prefer to live in close proximity to other people and need limited services, such as meals.

### Housing SA

Housing SA is the South Australian government's public housing provider. It provides public rental housing for low income households and people with special needs including a special housing program for Aboriginal people. There is usually a very long waiting list. A priority system applies. A large number of Housing SA houses have been transferred to community housing providers (See relevant section above).

Housing SA also provides financial assistance to eligible customers in the private rental market through Private Rental Assistance. Application forms are available from local offices and from [www.sa.gov.au](http://www.sa.gov.au).

### Renting in residential parks

Some residential parks provide the option to rent a dwelling (e.g. caravan or cabin). A residential parking tenancy agreement should be in place. ### Accommodation for people with a disability

Some community housing providers specialise in providing low cost rental accommodation for people with a disability. See section *Community Housing* above.

People who are registered with the National Disability Insurance Scheme (NDIS) may receive assistance to live independently, including, among other supports, 'home modifications to the participant's own home or a private rental property and on a case-by-case basis in social housing'.

The NDIS may be able to provide extra assistance to Scheme participants, such as a Local Area Coordinator to make contact and discuss their needs with housing providers, and funded support co-ordination to assist sourcing appropriate housing options.

The NDIS will only fund **Specialist Disability Accommodation (SDA)** when it is a reasonable and necessary support for a participant due to extreme functional impairment or very high support need. SDA payments are made by the NDIS to SDA property owners for the cost of housing a person with SDA funding allocated in their NDIS plan.

### The Housing Hub

It includes a portal where people can find disability-friendly properties across Australia. The website advertises vacancies for apartments and houses that are owned by housing providers. It also features a library of useful information about housing options and planning your move.

**Nest** (<https://gonest.com.au/>) is another online resource for people with disability and providers of housing suitable for people with disability. It lists properties available and can be searched by area. The website also features an A-Z directory of the organisations that list their vacancies on the database.

### Support for older people facing homelessness

**Assistance with Care and Housing** services are delivered under the Commonwealth Home Support to people aged 65 years and older and also to prematurely aged people 50 years and over (or 45 years and over for Aboriginal and Torres Strait Islander people), who are on a low income and who are homeless or at risk of homelessness as a result of experiencing housing stress or not having secure accommodation.
